

Covert and Overt

New book explores the historical relationships between covert intelligence work and information science

October 28, 2005, Medford, New Jersey—Information Today, Inc. (ITI) has announced the publication of Covert & Overt: Recollecting and Connecting Intelligence Service and Information Science, edited by Robert V. Williams and Ben-Ami Lipetz. This is the latest title in the ASIST Monograph Series published by ITI on behalf of the American Society for Information Science & Technology (ASIST), and represents a unique cooperation between ITI and Scarecrow Press, Inc., of Lanham, Maryland.

Covert and Overt is the first scholarly book to present an in-depth exploration of the historical relationships between covert intelligence work and information/computer science. Editors Williams and Lipetz contribute their own chapters along with those by intelligence professionals and technologists from a range of U.S. and British agencies and armed services. The book first examines the pivotal strides made during World War II to utilize technology in the gathering and dissemination of government/military intelligence. Next, it traces the evolution of the relationship between spymasters, computers, and systems developers through the years of the Cold War—a period notable for the parallel development of high-tech spyware and powerful systems for encoding, decoding, storing, and manipulating intelligence data.
