

# Annual Review of Information Science and Technology, Volume 43

## 2009 ARIST Volume Debuts at the Annual ASIS&T Conference

*October 27, 2008, Columbus, Ohio*—At the 2008 Annual Meeting of the American Society for Information Science and Technology (ASIS&T), Information Today, Inc. (ITI) announced the publication of Volume 43 of the *Annual Review of Information Science and Technology (ARIST)*.

*ARIST* is celebrated for contributing a comprehensive and insightful view of the field of information science and technology since 1966. The series encompasses all aspects of the field, with topics for the annual volume selected by editor Blaise Cronin. The range of topics varies considerably, reflecting the dynamism of the discipline and the diversity of theoretical and applied perspectives. While *ARIST* continues to cover topics associated with classical information science, the editor has selectively expanded its radius in an effort to connect information science more tightly with affiliated academic and professional communities.
